Target Market Summary

This product is likely to be appropriate for a consumer seeking **capital growth** to be used as a **satellite / small allocation** within a portfolio where the consumer has a **long** investment timeframe, **very high** risk/return profile.

This product is **not suitable** for a consumer seeking short term capital preservation, a capital guarantee, or regular income to be used by a consumer as a core component or standalone allocation within a portfolio where the consumer has a short to medium investment timeframe, or low to medium risk/return profile.

Investment products and diversification

Low	<p>The consumer is conservative or low risk in nature, seeks to minimise potential losses (e.g. has the ability to bear up to 1 negative return over a 20 year period (SRM 1 to 2)) and is comfortable with a low target return profile.</p> <p>Consumer typically prefers defensive assets such as cash and fixed income.</p>
Medium	<p>The consumer is moderate or medium risk in nature, seeking to minimise potential losses (e.g. has the ability to bear up to 4 negative returns over a 20 year period (SRM 3 to 5)) and comfortable with a moderate target return profile.</p> <p>Consumer typically prefers a balance of growth assets such as shares, property and alternative assets and defensive assets such as cash and fixed income.</p>

<p>Issuers should consider in the first instance the redemption request frequency under ordinary circumstances. Significant dealings	<p>Section 994F(6) of the Act requires distributors to notify the issuer if they become aware of a significant dealing in the product that is not consistent with the TMD.
