Growth of AUD \$100,000



Fund commentary

- Top contributors to the Fund in February were Apollo Global Management, Siemens AG, and our bank holdings ANZ and Westpac.
- Detractors included commodity holdings Stanmore Resources, Coronado Resources, Woodside Energy, and BHP.
- The Fund continued buying the real estate investment trust Centuria Industrial and added to its existing position in metallurgical coal miner Coronado Resources. The Fund took advantage of the disproportionate selloff in ING Group's stock post its full year result, topping up the position. ING shares have since recovered to their preresult levels.
- The Fund trimmed its position in Challenger Group, but did not exit any positions.
- The long equity position at month's end closed at 75%, with a net equity position of 73%. The Fund continues to hold an additional 13% in credit securities.
