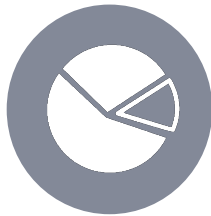
##### Opportunistic

With access to PM Capital's effective international research, the Fund can invest 0-20% in companies internationally if they provide better risk/ reward propositions than are present domestically.

To provide long term capital growth and outperform the greater of the S&P/ASX 200 Accumulation Index or the RBA cash rate over rolling seven year periods. The Fund is not intended to replicate the index.
